GINA LAGOMARSINO JUNIOR WARDEN


I am so grateful that I found St. C's 16 years ago. I have been transformed by this vibrant community that inspires me every day to Live God's Love.


CHARLES MOLLUZZO

ELIZABETH HAILE



ELECTION FAQS

Who is qualified to vote?

The Bylaws state: A "qualified voter" is a person who is: (a) at least 15 years of age; (b) a communicant in good standing of the Episcopal Church, as defined in Title I, Canon 17, Sections 1-3, of the Canons of the General Convention of the Protestant Episcopal Church; (c) a contributor of record to the Parish (which contributions may be cash offerings or services rendered to the Parish and known to the Treasurer); (d) recorded in the Parish register; and (e) who has, at the time of the Parish Meeting, met the foregoing requirements for a period of not less than one month.

When and how will voting done this year?

This year, voting will be conducted online beginning on November 1 and through paper balloting at St. Columba's on November 6 and 13. In order to vote online you must ensure that your email address is on record with St. Columba's in the online directory (Realm). All voting closes at 2pm on November 13.

Is my vote confidential?

Yes. Both online votes and paper ballot votes are confidential. There is no way to associate your name with your vote. Further, once votes are tallied, the voting records will be deleted or destroyed.

Will there be a Candidate Forum this year?

Yes. This year the Candidate Forum will be pre-recorded and available for viewing beginning November 1. All candidates will be introduced, and each nominee for vestry will comment on his or her experiences at St. Columba's and priorities for the parish.



ELECTION FAQS

What do wardens and the vestry do?

They are the elected voice of the laity at St. Columba's. The vestry consists of the rector; a senior and junior warden (the primary elected lay leaders of the congregation, who preside at vestry meetings in the rector's absence), elected to one-year terms; and 12 members, who are elected to three-year terms.

The vestry determines how to allocate the resources of the parish, serves as the legal representative for the parish's corporate property and provides formal feedback to the rector and the clergy.

What do Diocesan delegates do?

Delegates represent St. Columba's at the annual diocesan convention, which brings together clergy and lay members from all 88 congregations under the Bishop's leadership to decide the diocesan budget, elect members of various diocesan bodies and vote on special resolutions. The delegates also represent the congregation in other key forums, such as the Regional Assemblies each fall, when the Bishop meets with clergy and delegates from each of the diocese's six regions. St. Columba's diocesan delegates serve as an alternate for one year and then, are elected to a two-year term as a delegate.

How are candidates chosen?

Candidates for vestry and diocesan delegate are chosen by the Nominating Committee, which is headed by two vestry members. Candidates for warden are chosen by the rector. The 2023 Nominating Committee members are: Tom Bauder, Nicole Cannizzaro, Wayne Fowler, Elizabeth Gardiner, Charlotte Hart, Susan Garille Higgins, Matthew Huggins, Charlotte Jackson, , with cochairs Emily Lawson and Ryan McNavage.
